- CreditBank PNG is not liable for any Invalid Transaction or losses or inconveniences the Indemnitor incurs or those of a Card holder of any other person should a Terminal or communication line be faulty.
- The Indemnitor is liable for Invalid Transactions or any loss arising from unauthorised use of the Indemnitor's refund password.
- The indemnitor Agreement commences immediately on the date on which the Indemnitor accepts the installation of a Merchant Facility or when a Merchant Contract is signed.
